Account values will be credited with a guaranteed interest rate for the term you choose PLUS a percentage of the growth in the index over that same term. The amount credited is based on the performance of the S&P 500 Index and is applied to your account balance at the end of the term.

Guaranteed Interest Rate + Potential Credits Earned in the Index = Account Value

Increased Income During Retirement

The Preserve Plus offers an income bonus percentage, which is based on the number of guarantee terms completed. The percentage ranges from 2% to 8%.

Annuitization Liquidity

Preserve Plus offers flexibility in starting income payments when needed, while also providing a liquidity option. After receiving payments, clients may request that we commute up to 50% of your annuitization options benefits. A lump-sum distribution will reduce further income payments proportionally.
